5. NEW BUSINESS

Ms. Kellner is working on securing new façade grants.

She reported that:

- The "old" Chevron has opened as the "new" Chevron and once they get more established may be looking into a façade grant.
- Mimosa & Magnolia Boutique is opening soon.
- There were two ribbon cuttings this last week;
 - Bridges
 - Grafting Groomers
- Civic Hub and Blue Marlin have broken ground.
- Accent Electric is going up quickly. They are business to business, and do not want to attract residential walk-ins with signage.

Ms. Kellner reported the CRA Board meeting approved the upcoming Arts & Crafts Show.

B. Update: Public Relations Update

By motion of Amy Tidd, seconded by Janet Monaco, the Committee moved to remove the Public Relations Update topic from the meeting agenda. Motion passed unanimously.

C. Report: Economic Development Committee (EDC)/Liz Logan

Liz Logan attended a meeting that was a celebration of the local military; how the EDC was instrumental in the reversal of the Base Realignment and Closure recommendation, saving jobs. The new EDC Chair, Dana Kilborne was introduced and the volunteer of the year was awarded. There is a website that is the Business Voice of Florida's Space Coast, businessvoicepac.com.

Ms. Logan reported that the Rockledge Business Alliance (RBA) meeting had someone speak on Traction Florida, an entrepreneurial operating system.

D. Report: Projects Update

Alix Bernard reported on the following projects:

- The Food Truck is organized by Daily City and is being held on November 8th.
- November 8th is also the Kick-off of the Canned Food Drive November 8th December 13th at City Hall. It was suggested to have more frequent postings on the website and ask to be shared on the City's Facebook.
- Light Up Rockledge is scheduled for December 1st at 6:00 at City Hall.
- The Cocoa/Rockledge Holiday Parade will be held on December 13th starting from Rockledge High School. It is Rockledge's turn to play Santa.
- The Arts and Crafts Show on Barton is on the calendar for January 26 and 27, 2019.
- Two more senior living facilities have just submitted plans for Murrell and Barnes.

Alix Bernard reminded the members that the November meeting is a site visit, being held at the Space Coast Health Foundation on November 13, 2018, 5:30 p.m. at 1100 Rockledge Blvd (across from Arby's).

DISCUSSION:

Janet Monaco shared the story of collecting money and donating the bulk of the cost of a new "Bite Suit" to the Rockledge Police Department; donating food for Rockledge and Cocoa's K-9 teams; and donating for the purchase of a Heat Alarm system for the Rockledge K-9 teams.

Adam Copenhaver commented on how well he thought the Rockin' Nights Car Show went. It was noted that 136 cars participated and was a big success.

Dan Henn commented on National Night Out and what a great turn out there was.
