#### 7. NEW BUSINESS

A. Approval: Proposed Fiscal Year 2022-2023 Community Redevelopment Agency Budget

In addition, it has been deemed necessary by the Florida Auditor General for Community Redevelopment Agencies to undergo independent audits to ensure compliance with existing laws. An engagement letter from Carr, Riggs & Ingram, LLC was provided for the Commission's consideration.

Commissioner Lum moved to approve the engagement letter with Carr, Riggs & Ingram, LLC for Fiscal Year 2022 auditing services and to forward the recommendation to City Council; motion seconded by Commissioner Fearon. The motion carried without objection.
